- **This award is not applicable for private, commercial, instrument, multi-engine, CFI, CFII, ATP certificates, licenses or ratings.**

**WHEN?** Deadline for postmarked entries is **April 1, 2010.**

**QUALIFICATIONS:** Female candidate must possess a pilot's certificate and complete and send in the application form which must be postmarked by the due date, **April 1, 2010.**

**APPLICATION:** Includes resume with contact information, two (2) one page letters of recommendation from persons who have knowledge of applicant (see attached application for specifics), copies of all aviation certificates (including pilot and medical), and 150-200 word typed essay describing applicant (schooling, profession, flight experience, etc.), how the monies will be used and why you think you should be awarded this scholarship.
