

PARENTAL CONSENT, RELEASE, AND INDEMNIFICATION
(For Parents/Legal Guardians of Minor Racers)

This Parental Consent, Release, and Indemnification Agreement ("Agreement") is entered into by the undersigned parent or guardian of the below-named participant in the Air Race Classic or other ARC Event.

1. Definitions.

(a) "ARC" means Air Race Classic, Inc., and its officers, directors, employees, agents, volunteers, committees, officials, and affiliated organizations.

(b) "Released Parties" means Air Race Classic, Inc., and its past, present, and future officers, directors, employees, agents, volunteers, committee members, race officials, contractors, and affiliated organizations, together with each airport, airport authority, airport sponsor, municipality, governmental entity, fixed-base operator, or other property owner or operator that hosts, supports, permits, or facilitates any portion of the Air Race Classic or any ARC Event (including without limitation the Start Airport, Terminus Airport, and any interim stop or diversion airport), and each of their respective officers, directors, employees, agents, and volunteers.

(c) "Minor Racer" means the undersigned parent's or legal guardian's child who is under eighteen (18) years of age and is participating as a pilot and/or team member in the Air Race Classic and any related ARC-sponsored activities, events, inspections, briefings, ceremonies, media activities, and other ARC Events.

2. Parental Consent to Participation; Acknowledgment of Risk.

I am the parent or legal guardian of the Minor Racer identified below. I knowingly and voluntarily consent to the Minor Racer's participation in ARC Events. I understand and acknowledge that aviation and competitive flight activities involve inherent and significant risks, including the risk of serious bodily injury, death, and property damage.

3. Confirmation of Separate Racer Release and ARC Documents.

I understand and acknowledge that, as a condition of participation, the Minor Racer must execute ARC's separate Liability, Waiver, and Release Agreement (C-02). I further confirm that I and the Minor Racer have reviewed the ARC Registration Terms and Conditions and the ARC Rules, and that participation is conditioned on compliance with all such requirements.

4. Pilot in Command; Reliance on Information at Own Risk.

It is my understanding that the pilot of each aircraft is in full and complete charge and control of that aircraft and is responsible for all decisions concerning operation, safety, and compliance. ARC officials may provide information concerning weather, airport conditions, routing

information, and similar guidance, but I understand that the Minor Racer acts or relies on any such information at her own peril and that ARC assumes no responsibility for the completeness or accuracy of such information.

5. Limited Purpose of Aircraft Inspection.

It is my understanding that any inspection by ARC officials is solely for determining whether an aircraft complies with ARC eligibility rules and does not constitute a representation or warranty of any kind concerning mechanical condition or airworthiness.

6. Briefings.

I confirm that the Minor Racer has completed or will complete prior to race start any ARC online briefings and will attend all ARC mandatory in-person briefings required for participation.

7. Release of Parent's Own Claims Only.

To the fullest extent permitted by law, I, for myself and my heirs, assigns, and personal representatives, hereby release and forever discharge the Released Parties from any and all claims, demands, liabilities, or causes of action that I personally may have, whether known or unknown, arising out of or related to the Minor Racer's participation in any ARC Event, including claims based on the ordinary negligence of the Released Parties.

This release applies only to my own claims and does not purport to release claims belonging to the Minor Racer except to the extent permitted by applicable law.

8. Parental Indemnification; Defense; Hold Harmless.

To the fullest extent permitted by law, I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all claims, demands, liabilities, damages, judgments, settlements, costs, and expenses (including reasonable attorneys' fees) arising out of or related to the Minor Racer's participation in any ARC Event, including claims brought by or on behalf of the Minor Racer, the Minor Racer's estate, family members, insurers, or third parties. This indemnity does not apply to the extent a court of competent jurisdiction finally determines that a claim was caused by the Released Parties' gross negligence or willful misconduct where such indemnification is prohibited by applicable law.

9. Media Permission.

I give ARC permission to use photographs, images, video, audio, interviews, and the Minor Racer's name and likeness captured during ARC Events in ARC promotional, educational, and other materials, without compensation.

10. No Adult Supervision.

I acknowledge that ARC is not responsible for providing adult supervision for the Minor Racer.

11. Emergency Medical Authorization; Limited Disclosure.

In case of emergency, I understand reasonable effort will be made to contact me. If I cannot be reached after reasonable efforts, I authorize ARC officials (or their designee) to obtain emergency medical evaluation and treatment for the Minor Racer, as determined by a licensed health-care practitioner, including hospitalization and medically necessary procedures. I authorize medical providers to disclose to ARC officials information reasonably necessary to facilitate emergency treatment and coordination.

12. Governing Law; Venue; Severability.

This Agreement shall be governed by the laws of the State of North Carolina, without regard to conflict-of-law principles. Exclusive venue and jurisdiction for any action or proceeding arising out of or relating to this Agreement or any ARC Event shall lie in the courts specified in ARC's Registration Terms and Conditions. If any provision is held unenforceable, the remaining provisions shall remain in full force and effect.
